The onsite Coca Cola chemist stated that the personnel was adding a type of UN1908 Chlorite Solution to a (1) 330-gallon metal tote. They were adding the solution by hand and accidentally poured the substance to fast which caused the solution of off gas. The personnel then moved the tote outside and called the fire department. The fire department added water to the tote which reacted. The reaction caused the metal tote to explode causing the personnel hand to blow off.
