AT APPROXIMATE 04:15 AM ON I-10 EASTBOUND IN WINNIE, TX, A HYDROGEN TUBE TRAILER EXPERIENCED A TIRE FIRE AND PULLED ONTO THE SHOULDER. THE DRIVER ATTEMPTED TO EXTINGUISH THE FIRE WITH THE FIRE EXTINGUISHER THAT WAS ON THE VEHICLE. HEAT FROM THE FIRE CAUSED SEALS ON THE ISOLATION VALVES OF TWO TUBES TO DEFORM AND THE WELDED STAINLESS STEEL MANIFOLD TO CRACK, RELEASING HYDROGEN. THE HYDROGEN GAS THAT WAS RELEASED WAS IGNITED BY THE TIRE FIRE. CONSEQUENTLY, THE DRIVER WAS UNABLE TO EXTINGUISH THE FIRE AND CALLED 911. EMERGENCY RESPONDERS FROM WINNIE, TX RESPONDED AND I-10 WAS CLOSED IN BOTH DIRECTIONS FOR SEVERAL HOURS. THERE WERE NO FATALITIES, NO INJURIES, AND DAMAGE WAS LIMITED TO THE TRAILER.
