### Describe:

A 300 GALLON POLY TOTE TANK CAUSTIC SODA 50% WAS BEING UNLOADED FROM A VAN WATERS & ROGERS TRUCK. THE TOTE TANK WAS TAKEN TO THE REAR OF THE TRUCK USING AN ELECTRIC PALLET JACK. THERE WAS NO LOADING DOCK, SO THE CUSTOMER WAS APPROACHING THE REAR OF THE TRUCK WITH THEIR FORKLIFT TO UNLOAD. THE PALLET JACK CAME UPON A RIDGE IN THE TRUCK'S BED WHICH FORCED IT FORWARDED. THE MOMENTUM OF THE LIQUID CARRIED THE TOTE TANK FORWARD AND IT FELL OFF THE BACK OF THE TRUCK APPROXIMATELY 45 INCHES FROM THE GROUND. THE TOTE LANDED ON ITS SIDE AND THE IMPACT OF THE FALL SPLIT THE CAP ON THE TOTE. APPROXIMATELY 150 GALLONS OF CAUSTIC SODA 50% SPILLED ONTO THE LOADING AREA AND SPREAD OVER AN AREA OF ABOUT 40 x 50 FEET. IN THE FUTURE, A ELECTRIC PALLET JACK WILL NOT BE USED FOR THE UNLOADING OF POLY TOTE TANKS BECAUSE YOU DON'T HAVE AS MUCH CONTROL AS YOU WOULD IF USING A MANUAL PALLET JACK. THIS INCIDENT DID NOT OCCUR DUE TO FAULTY PACKAGING, BUT WAS THE RESULT OF IMPROPER UNLOADING MEASURES.
