DRIVER WAS IN ROUTE TO CUSTOMER JOB LOCATION (FRAC SITE) TO DELIVER FUEL IN ORLA, TEXAS VIA HWY 285. DRIVER VEERED OFF THE ROAD AND ROLLED THE TRACTOR/TRANSPORT ONTO ITS SIDE. THE IMPACT OF THE TRANSPORT HITTING THE GROUND CAUSED THE TRANSPORT TANK WALLS TO RUPTURE AND TEAR IN CERTAIN AREAS RESULTING IN A RELEASE OF MATERIAL ONTO THE SHOULDER AREA. A SPILL RESPONSE TEAM WAS DISPATCHED AND REMEDIATION COMMENCED. APPROPRIATE AUTHORITIES WERE NOTIFIED INCLUDING THE EPA AND TCEQ.
