ON DECEMBER 19, 1998, AT APPROXIMATELY 1700 HOURS A RAILROAD TANK CAR, NUMBER GATX 54669, LOADED WITH CYCLOHEXANE, WAS OBSERVED LEAKING FROM A DEFECTIVE BOTTOM OUTLET VALVE WHILE BEING SWITCHED AT KCS BEAUMONT, TEXAS RAIL YARD. THE TANK CAR WAS IMMEDIATELY ISOLATED TO THE NORTH END OF TRACK #5 AND A BUCKET WAS PLACED UNDER THE LEAK. THE SHIPPER (RESPONSIBLE PARTY) WAS IMMEDIATELY NOTIFIED AND RESPONDED TO THE SCENE. ALL REQUIRED LOCAL, STATE & FEDERAL NOTIFICATIONS WERE IMMEDIATELY PERFORMED BY KCS. AS A PRECAUTION, LOCAL AUTHORITIES CLOSED 0.25 MILE PORTION OF MARTIN LUTHER KING PKWY AND APPROXIMATELY 1 CITY BLOCK OF WASHINGTON STREET. THE SHIPPER'S RESPONSE CREW REPAIRED THE DEFECTIVE BOTTOM OUTLET VALVE AT 1830 HOURS THAT SAME DAY. LOCAL OFFICIALS SUBSEQUENTLY OPENED ALL STREETS AT 2100 HOURS. THE SHIPPERS ENVIRONMENTAL RESPONSE CONTRACTOR DECONTAMINATED THE AFFECTED AREAS AS REQUIRED BY THE TEXAS NATURAL RESOURCE CONSERVATION COMMISSION.
