MANLEY-REGAN CHEMICALS' TRUCK ARRIVED AT CUSTOMER TO DELIVER PORTABLE TANK OF SODIUM HYDROXIDE SOLUTION. LOADING DOCKS WERE NOT AVAILABLE AT TIME SO MANLEY-REGAN DRIVER WAS DIRECTED TO ANOTHER AREA TO OFFLOAD. THIS AREA DOES NOT HAVE A DOCK ARRANGEMENT AND REQUIRED DRIVER TO MOVE PORTBLE TANK WITH PALLET JACK TO REAR OF TRAILER. DRIVER COULD NOT STOP LOAD AT REAR OF TRAILER AND THEREBY "FLIPPED" PORTABLE TANK OFF OF REAR OF TRAILER ONTO SIDE. TOP OF TANK SPLIT OPEN LOSING CONTENTS ONTO CONCRETE UNLOADING AREA. SPILL CLEAN UP WAS PERFORMED UNDER DIRECTION OF PA DEPT OF ENVIRONMENTAL RESOURCES. MANLEY-REGAN CHEMICALS' POLICY IS TO ONLY HANDLE PORTABLE WITH FORKLITS. DRIVER WAS REPRIMANDED AND ALL CUSTOMERS WERE NOTIFIED THAT THE POLICY WILL BE ENFORCED.
