TRANSPORT DELIVERY UNIT WAS CONNECTED TO THE BULK STORAGE TANK AND WAS IN THE PROCESS OF OFF-LOADING. THE DRIVER FAILED TO NOTICE THAT THE BRAKES ON THE TRANSPORT HAD NOT SET AND THAT THE UNIT WAS IN A NEUTRAL POSITION. WITH THE VIBRATION OF THE LIQUID PUMP OFF-LOADING, THE VEHICLE BEGAN TO ROLL FORWARD. THE HOSES WERE ATTACHED AND BEGAN TO STRETCH. AT THE MAXIMUM DISTANCE OF THE HOSES, THE PIPING ON THE BULK STATION FAILED BY DESIGN AND THE EMERGENCY SHUT-OFFS REACTED. ALL VALVES WERE SHUT BY DESIGN AND THE RELEASE WAS CONTAINED. THE DRIVER RAN FORWARD OF THE VEHICLE AND JUMPED INTO THE MOVING TRUCK CAB. HE APPLIED THE FOOT PEDAL AND PROPERLY SET THE PARKING BRAKES. DUE TO THE RELEASE OF PRODUCT, THE DISTRICT INITIATED AN EMERGENCY EVACUATION AND CONTACTED LOCAL AUTHORITIES FOR AN EMERGENCY RESPONSE. THE GAS CLOUD DISSIPATED AND THE SITUATION WAS UNDER CONTROL. LOCAL AND STATE AUTHORITIES INSPECTED THE TRANSPORT AND DISCOVERED A FAULTY AIR VALVE. THE UNIT WAS PLACED OUT OF SERVICE AND REPAIRED. THE BULK STORAGE WAS REPAIRED AND RETURNED TO SERVICE.
