Release Information:

Approximately 40 gallons of diesel leaked from the tanker as a result of the accident. An estimated 400 gallons of ethanol leaked from the initial roll over. The tractor was on its driver side with the tanker in the ditch (Picture 1). The BSCFD applied floor dry to the spilled diesel and created an earthen berm down stream from the tanker to prevent any ethanol from reaching a wetland should the tanker leak.
