EMERGENCY RESPONSE PERSONNEL FROM THE ILLINOIS CENTRAL DUG A PIT TO CONTAIN LIQUID AND PUT SODIUM BICARBONATE DOWN TO NEUTRALIZE ACID. RHONE POULNEC EMERGENCY RESPONSE PERSONNEL IN LEVEL "A" SUITES STOPPED LEAK BY DRIVING WOODEN WEDGES INTO HOLE AT WELD NEAR BOTTOM OUTLET. LOAD WAS TRANSFERRED TO TANK CAR RPBX 17148. CAUSE OF NAR, INNER LINER FAILURE.
