UPON ARRIVAL AT ANCHORAGE (MP 123), IT WAS NOTED THAT THE ENTIRE CONTENTS (20,123) GALLONS) OF PRODUCT FROM TANK CAR ARR 9306 HAD BEEN RELEASED. INSPECTION REVEALED THAT THE BOTTOM OUTLET VALVE WAS OPEN AND THE BOTTOM OUTLET CAP CAME OFF AT WASILLA (MP 158.5), RESULTING IN PRODUCT RELEASE AS THE CAR TRAVELED SOUTH TO ANCHORAGE. NO INJURY, FIRE OR EVACUATION RESULTED FROM THE RELEASE OF THIS HAZARDOUS MATERIAL. BECAUSE OF THE TRAIN SPEED, PRODUCT WAS SPREAD EVENLY OVER AN AREA 35.5 MILES LONG. THEREFORE, VERY LITTLE MATERIAL WAS RECOVERED; HOWEVER, FOR THE SAME REASON VERY LITTLE ENVIRONMENTAL DAMAGE WAS SUSTAINED.
