DRIVER, WHILE TRAVELING ON ROADWAY, REACHED TO FLOOR TO PICK UP AN ITEM. TRUCK DRIFTED TO THE POINT A STEER TIRE LEFT THE ASPHALT ON LEFT SIDE. DRIVER SLOWED, THEN ATTEMPTED TO STEER BACK ONTO ROADWAY. THE TRAILER THEN JACKKNIFED AWAY FROM ROADWAY. TRACTOR AND TRAILER ROLLED IN A CORK SCREW MOTION 3/4 OR A REVOLUTION, COMING TO REST ON THE PASSENGER SIDE. PACKAGE FAILURE DUE TO ABRASION OF FROZEN GROUND AND ASPHALT. TRAILER WAS DENTED SOMEWHAT FLAT ON BOTH SIDES. EMERGENCY PERSONNEL ALONG WITH ENVIRONMENTAL FIRMS, USE PETROLEUM ABSORBENT BOOMS TO CONTAIN LEAKAGE AND WIPES TO REMOVE LIQUID FROM GROUND. DURATION OF RELEASE WAS APPROXIMATELY 6 1/2 HOURS.
