WHILE TRAVELING ON I 65 NB TRAFFIC CAME TO A SUDDEN STOP. THE TRACTOR -TRAILER TRAVELING IN FRONT OF OUR UNIT JACK-KNIFED. OUR UNIT COLLIDED WITH THIS TRACTOR TRAILER, CROSSED OVER THE MEDIAN AND THE 5B LANES AND CAME TO REST IN THE TREE LINE OFF THE SHOULDER OF THE ROADWAY. THE TANK BECAME GOUGED AND APPROX 150 GAL OF MOTOR OIL WAS ABLE TO SPILL ONTO THE SOFT SHOULDER. THE FIRE DEPT WAS IMMEDIATELY NOTIFIED ALONG WITH UNITED STATES ENVIRONMENTAL SERVICES TO CONTROL THE SPILL AND TO HANDLE THE REMEDIATION. REMEDIATION HAS MET THE APPROVAL OF ADEM.
