A WORKER CLOSED THE TANK VALVE ON A TANKER TRAILER TO REMOVE A FILL HOSE FROM THE TANKER LEADING TO A STORAGE TANK IN ORDER TO CLEAN THE HOSE. THE VALVE DID NOT CLOSE FULLY. WHEN THE MATERIAL IN THE TANKER OUTLET VALVE MELTED, MALEIC ANHYDRIDE SPILLED INTO CONTAINMENT AND ONTO CONCRETE PAVEMENT. THE MALEIC ANHYDRIDE RAPIDLY SOLIDIFIED AS IT COOLED TO BELOW 127 DEGREES FAHRENHEIT. NO MATERIAL LEFT THE FACILITY, AND THERE WERE NO ENVIRONMENTAL RISK BEYOND THE IMMEDIATE AREA.
