ECOLOGY & ENVIRONMENT IS ON RETAINER TO BONCOSKY AND WAS SUMMONED TO THE ACCIDENT SITE. E & E IS AN INDEPENDANT HAZARD SPILL COMPANY. LOAD WAS TRANSFERRED. ALL CONTAMINATED WATER AND SOIL WAS REMOVED AND TRANSPORTED BY A LICENSED HAZARDOUS WASTE TRANSPORTER TO A LICENSED HAZARDOUS WASTE DISPOSAL SITE. ALL CLEAN UP WAS COMPLETED AND HAS BEEN APPROVED BY THE OHIO EPA.
