On March 10, 2016 at 11:28 hours personnel in the CSX Boyles Yard reported GATX 2947, a loaded tank car of Carbon Dioxide, venting loudly. The car was isolated and the shipper, Air Liquide, was notified (CHEMTREC Report # 2016-03-10-00159). USES, a CSX response contractor, was dispatched to the scene and found the frangible disc in the non-reclosing pressure relief device had ruptured. The issue identified and corrective actions were communicated to the shippers representative James Montalbano (713-896-2316). After allowing the car to relieve the necessary pressure, CSX Hazardous Material Team personnel returned to the site on March 12, 2016 and installed a new rupture disc. The car will be held out of transportation until such time that the internal temperature of the car rises to a level that is safe for transportation.
