AN EMPLOYEE WAS TRANSFERRING 50% CAUSTIC FROM A RAILCAR LOCATED ON OUR SIDING TO OUT 10,000 GALLON STORAGE TANK. THE FITTING ON OUR 2" TRANSFER HOSE IS MADE OF POLYPROPYLENE AND IT BROKE AT THE POINT WHERE IT CONNECTS TO THE RAILCAR, RESULTING IN A DISCHARGE OF APPROXIMATELY 125 GALLONS ON TO THE GROUND. THE PRODUCT WAS COLLECTED, NEUTRALIZED AND PUMPED INTO OUR SURFACE IMPOUNDMENT AREA. WE FEEL THE FITTINGS PROBABLE WEAKENED AND BECAME BRITTLE OVER TIME CAUSING IT TO BREAK. WE WILL REPLACE OUR RAILCAR POLYPROPYLENE HOSE FITTINGS WITH STAINLESS STEEL FITTINGS WHICH SOULD ELIMINATE THE POSSIBLITY OF THIS HAPPENING AGAIN.
