Had a catastrophic failure to a 55 gallon 1H1 due to pressure buildup. The manufacture did not have a vented bung in the drum. The drum split on the side close to the bottom. The fire department responded and controlled the scene. SET Environmental was called out to handle the remediation. Vented Bungs were placed on the other 15 drums after they were vented to prevent any other release.
