ALL WE WERE ABLE TO DETERMINE THAT MIGHT HAVE POSSIBLY CAUSED THE LEAK WAS A SMALL WOOD SCREW IN FLOOR PENETRATED CONTAINER CAUSING LEAKAGE. NO OTHER DAMAGE INVOLVED OTHER THAN THE CLEANUP AND CONTAINMENT OF THE REMAINDER OF THE ONE DRUM.
