OUR UNIT WAS EXITING FROM I - 95 SOUTH TO RT 37 EAST WHEN THE TRUCK ROLLED OVER ON THE EXIT RAMP, CAUSING JET FUEL LEAK FROM THE TANKER ONTO THE EXIT RAMP AND DOWN AN EMBANKMENT AND INTO THE PAWTUCKET RIVER. A CAR THEN DROVE THREW THE JET FUEL, BELIEVING IT WAS WATER. THE HEAT FROM THE CAR'S EXHAUST SYSTEM CAUGHT THE JET FUEL ON FIRE, AND THE FIRE TRAILED BACK TO THE TANKER CAUSING IT TO EXPLODE INTO FLAMES. THE HEAT FROM THE FIRE DAMAGED AN OVERPASS ONTO RT 37. DUE TO THE FIRE DAMAGE TO THE TANKER IT IS NOT POSSIBLE TO DETERMINE WHERE THE JET FUEL ESCAPED FROM.
