Transportation Vessel loaded in tank farm. Driver neglected to disconnect shipper loading arm when load process completed. Driver moved vehicle forward with shipper loading arm attached to transport trailer bending / breaking piping and releasing product. About 141 gallons of diesel fuel migrated directly into the shipper containment vault. No soil or waterways were impacted. All product was contained for proper disposal.
