Two Ferrellgas employees had finished filling a bobtail truck. They were putting the hose attached to the stationary tank back in the hose rack. The clip was missing on the ball valve. The valve caught on the side of the rack handle and it opened, spraying one employee with propane. The employee was treated and released the same day for minor burns, first degree burn on one leg, second degree burn in groin area. The employee returned to work in full duty capacity on February 17, 2009.
