PSC-IOG OF LAFAYETTE, LA WAS CONTACTED TO PERFORM THE CLEANUP. PSC-IOG PERFORMED THE CLEANUP USING SHOVELS, RAKES AND A BOBCAT. PSC-IOG PLACED THE CLEANUP MATERIALS AND CONTAMINATED LIMESTONE AND DEBRIS INTO ONE, ROLL-OFF BOX WHICH WAS BROUGHT TO THE EAGLEBROOK, INC. FACILITY IN PEARLINGTON, MS WHERE IT WILL BE HELD FOR DISPOSAL. NO INJURIES OR EXPOSURES WERE REPORTED. THE MSDS WAS REQUESTED AND RECEIVED. ALL FEDERAL, STATE, AND LOCAL REGULATORY AGENCIES WERE NOTIFIED.
