WHILE PERFORMING THEIR CAR INSPECTIONS IN OUR SAN YSIDRO YARD AT AROUND 0600, ANDERSON CAR REPAIR EMPLOYEES SMELLED LPG. CLIMBING ON TOP OF CAR GATX 205686 AND OPENING THE DOME THEY OBSERVED "ICING" ON ONE OF THE VALVES, AN NON-ACCIDENTAL RELEASE, THEY PROCEEDED TO TIGHTEN THE VALVE BY HAND WHICH STOPPED THE LEAK. THE TRAIN CREW DID NOT REPORT ANY SMELL DURING THEIR TRAIN INSPECTION AT 0100. ESTIMATED DURATION OF LEAK, APPROXIMATELY 4-5 HOURS. THE FOLLOWING ENTITIES WERE NOTIFIED ON 10/13/11 BETWEEN THE HOURS OF 0800 AND 1200 AND THEIR ACTIONS ARE NOTED:

SAN DIEGO FIRE/HAZMAT, ARRIVED ON SCENE AND CONFIRMED THAT THE LPG WAS NO LONGER LEAKING, NO REPORT ISSUED.

SAN DIEGO COUNTY ENVIRONMENTAL & HEALTH, NOTIFIED, NO REPORT ISSUED.

NRC, NOTIFIED, NO REPORT ISSUED.

US EPA #9, NOTIFIED, NO REPORT ISSUED.

COOPA, NOTIFIED, CONTROL #11-6119 ISSUED.

REPORT WAS DELAYED DUE TO WAITING FOR REQUIRED INFORMATION FROM THE CUSTOMER, WHO IS LOCATED IN MEXICO AND THE CAR OWNER GATX.
