On 07/03/2010 JRSX 1009 was reported as leaking in the Davidson Yard. Reg. Mgr. M. Kelly responded and found that the car was leaking from the connection between the bottom outlet valve and the bottom of the tank. Kelly was unable to stop the leak so he transloaded the product out of the car. After the car was transloaded and cleaned Kelly inspected the car and found that four of the eight Bolts that secured the bottom outlet valve to the tank were less than tool tight and that the gasket between the bottom outlet valve and the tank was severely deteriorated to the point that it would not contain the product. The car is B/O awaiting repairs.
