Driver began loading process on the cargo tank. The tank was being filled with Molten Sulfur. The driver by-passed the shutoff switch, sat on a crate, and fell asleep. The tank overfilled approximately 500 gallons spilling Molten Sulfur on the ground at the loading plant. Driver was awakened by another employee and the shut off switch was engaged stopping the flow. There were no defects on the trailer that caused the spill. Human error was the root cause. The spill was cleaned up by a qualified contractor. The spilled material was recovered and recycled at the shipper location.
