PETROLEUM TANKER WAS TRAVELING BEHIND OTHER TRACTOR TRAILERS THAT WERE WAITING IN LINE TO FUEL AT TRUCK STOP. THE LEFT REAR SIDE OF THE TANKER STRUCK THE REAR OF A DRY, TEARING A HOLE IN THE LEFT REAR COMPARTMENT OF THE TANKER. JET FUELED FLOWED FROM THE TEAR ONTO THE GROUND FOR ABOUT 60 FEET TO A STORM DRAIN WHERE IT WAS CONTAINED IN THE STORM DRAIN LINE AND THE RETENTION POND WHERE THE DRAIN LINE EMPTIED. THE FIRE DEPARTMENT AND THE SHERIFFS DEPARTMENT RESPONDED TO THE SCENE. THE TRUCK STOP WAS CLOSED FOR APPROXIMATELY 3.5 HOURS UNTIL THE SCENE WAS DEEMED SAFE FOR OPERATION BY THE FD. RHINO SERVICES HAS BEEN RETAINED TO MITIGATE THE SPILLED PRODUCT.
