While refilling an AST, the flex hose connected to the suction end of the PTO pump failed. The approximately 2-3 foot long hose developed a 2-3 inch crack along its horizontal axis.

The fuel spilled was contained on the asphalt. A cleanup crew was dispatched to re-mediate the spill.
