WE WERE NOT ABLE TO DETERMINE FOR CERTAIN THE EXACT CAUSE OF THE INCIDENT BUT HAVE THEORIZED THAT A UNIVERSAL JOINT IN THE SHORT DRIVELINE BETWEEN THE DIFFERENTIALS FAILED CAUSING THE DRIVELINE TO WHIP AROUND AND TEAR LOOSE THE FUEL PIPING UNDERNEATH THE CARGO TANK. THIS IN TURN CAUSED A FUEL LEAK WHICH WAS IGNITED BY THE SPARKING FROM THE BROKEN DRIVELINE.

BECAUSE OF THE REMOTE LOCATION OF THE TRUCK AND THE ADVANCED CONDITION OF THE FIRE, BY THE TIME THE FIRE DEPARTMENT ARRIVED, THEY DETERMINED THAT THE BEST COURSE OF ACTION WAS TO ALLOW THE FIRE TO BURN ITSELF OUT, MOSTLY CONSUMING THE TRUCK AND THE CARGO.
