PART VI - DESCRIPTION OF EVENTS & PACKAGE FAILURE

Describe:

A FORK BLADE HAD PUNCTURED A HOLE NEAR THE BOTTOM OF ONE PAIL THAT WAS LOADED ON A SHRINK WRAPPED PALLET OF 20 PAILS. THE PAILS WAS LOCATED ON THE BOTTOM ROW OF PAILS. AT TIME OF DISCOVERY THE PALLET WAS TAKEN OFF THE TRAILER AND PUT ON THE DOCK AND THE LEAKING PAIL WAS REMOVED FROM THE PALLET. ABSORBENT WAS PUT ON THE AREA OF DOCK AND TRAILER WHERE THE CONTENTS HAD LEAKED. A DISCUSSION WAS HELD ABOUT PROPERLY LOADING HAZARDOUS MATERIALS WITH A FORK LIFT TO KEEP FROM PUNCTURING CONTAINERS AND THE PROPER USE OF POSITION THAT FORKLIFT FORKS ARE TO BE USED IN MOVING HAZARDOUS MATERIALS THAT ARE LOADED ON PALLETS. ONE DRIVER WAS INJURED BY THIS SPILL. SOMETHING LEAKING OUT OF THE BACK OF THE TRAILER. THE TRAILER WAS BACKED INTO THE DOCK AND THEN THE TRAILER DOOR WAS RAISED. SOME OF THE SUBSTANCE WAS DRIPPING OFF THE BOTTOM OF THE TRAILER DOOR. SOMEHOW THE DRIVER CAME IN CONTACT WITH THIS SUBSTANCE - EITHER SOME GOT INTO HIS RIGHT EYE OR HE MAY HAVE RUBBED HIS EYE AFTER COMING IN CONTACT WITH THE SUBSTANCE. HE RECEIVED MEDICAL ATTENTION AT THE EMERGENCY ROOM AND MISSED 2 DAYS OF WORK. HE HAS BEEN RELEASED TO WORK WITH NO RESTRICTIONS.
