THE DRIVER WAS UNLOADING DIESEL FUEL AT OUR STORAGE TANK. HE THOUGHT HE WAS HOOKED TO TANK #15, UT WAS HOOKED TO TANK #20. THE CAPACITY ON TANK 20 WOULD NOT HOLD THE AMOUNT OF PRODUCT HE UNLOADED. ALL OF THE OVERFILL WAS CONTAINED INSIDE THE CONTAINMENT WALL. THE DIESEL WAS SUCKED UP AND STRAINED. THE AREA WAS CLEANED AND SPRAYED WITH AN EMULSIFYING PRODUCT TO CLEAR ANY RESIDUE FROM THE CONCRETE. THE DRIVER WAS REMINDED OF THE CORRECT PROCEDURE AND MARKINGS ON THE MANIFOLD SYSTEM WHILE UNLOADING.
