The dump truck driver attempted to avoid hitting another vehicle, and drove off the road into the median. The open top drum truck rolled over and released approximately 10 tons of UN3077 Haz waste onto the soil median and both the North and South bound lanes of I-75. The remaining material was offloaded from the truck onto the median, in order for the truck to be hauled offsite. All material was cleaned off the roadway using heavy equipment. All of the released product was loaded into rolloff boxes and hauled offsite.
