WAGUESPACH OIL CO. DRIVER PULLED UP TO THE OFFLOAD SITE TO PUMP OFF 8000 GALLONS OF OFFLOAD DIESEL. THE DRIVER DID NOT FOLLOW PROPER UNLOADING PROCEDURE THAT IS REQUIRED BY WAGUESPACH OIL CO. THE TANK OVERFLOWED AND A RELEASE OF DIESEL FLOWED INTO MARSH AND THE CANAL. THE RELEASE WAS QUICKLY CONTAINED AND (STATE TROOPER) HAZMAT WAS CALLED RIGHT AWAY. ES&H CLEANUP CREW WAS CALLED TO THE SCENE AND AS OF MONDAY, SEPT.12, 2011 THE REMEDIATION WAS DONE. THE SPILL OCCURRED BECAUSE THE DRIVER DID FOLLOW PROPER UNLOADING POLICY.
