UPON INSPECTION, THE BURST DISC WAS FOUND TO BE RUPTURED, ALLOWING PRODUCT TO ESCAPE TO THE ATMOSPHERE. THE RAILCAR WAS ISOLATED AND THE BURST DISC WAS REPLACED BY THE SHIPPER AND THE RAILCAR WAS FORWARDED TO DESTINATION.
