While en route to Johnson City, a 150-lb sulfur dioxide cylinder fell off the truck. It was then hit by a car causing a puncture and releasing the contents. Another car drove through the vapor cloud.

The Kingsport Fire Department responded and DPC hired a third party to respond to the incident. The cylinder was placed in a containment vessel for transport back to the facility.
