WHILE LOADING A TOTE ONTO OUR TRAILER, THE FORKLIFT DRIVER TURNED AND WHEN HE TURNED THE TOTE TIPPED OVER, THE TOTE IS TALL AND TOP HEAVY, AND LANDED ON A YELLOW CONCRETE POLL. WHEN THE TOTE HIT THE POLL THE PRESSURE POPPED THE LID OFF AND LIQUID SPRAYED ON THE FLOOR. THE DRIVER OF THE FORKLIFT, IN A PANIC, MOVED THE LIFT OUT FROM UNDER THE TOTE AND WHEN HE DID THE TOTE FELL ALL THE WAY OVER. THE TOTE WAS QUICKLY PICKED UP AND EMPLOYEES WERE EVACUATED. WE LOST APPROX. 350 GALLONS. NO INJURIES. THE DOCK PLATE IS SLOPPED AND THE DRIVER CAME IN AT AN ANGLE, CAUSING THE TOTE TO BE TO TIP. WE HAVE EXPLAINED TO THE DRIVER THAT HE NEEDS TO APPROACH THE TRUCK AND DOCK PLATE STRAIGHT AHEAD.
