THIS VEHICLE WAS TRAVELING NORTH ON I-55 IN THE VICINITY OF HERNANDO, MS. THE ROAD CONDITIONS WERE HAZARDOUS TO HEAVY RAINFALL. ALL TRAFFIC WAS MOVING SLOWLY DUE TO HEAVY RAINFALL AND BECAUSE THIS WAS A CONSTRUCTION ZONE AREA. WITNESSES ESTIMATED OUR VEHICLE'S SPEED TO BE BETWEEN 40 & 50 MPH. OUR VEHICLE WAS PASSING OTHER VEHICLES AND AS IT PROCEEDED TO MOVE BACK INTO THE RIGHT LANE, THE DRIVER APPLIED THE BRAKES. THE VEHICLE THEN PROCEEDED TO SKID, AND UPON REACHING THE SHOULDER OF THE ROAD, IT BEGAN TO OVERTURN. THE CARGO TANK, MOUNTED ON THE VEHICLE WAS RUPTURED AND SPILLED IT'S CONTENTS. THE MISSISSIPPI STATE TROOPER, CALLED TO THE SCENE, SHUT DOWN THE NORTH BOUND LANE OF I-55 FOR A VERY SHORT PERIOD OF TIME, UNTIL THE TANK CONTENTS WERE EMPTIED.
