HE OPENED THE DOME AND PROCEEDED TO TRANSFER PRODUCT TO HIS TRAILER. AS HE FINISHED LOADING HE NOTED PRODUCT RUNNING ON THE GROUND. HE RAN DOWN OFF THE LOADING RACK AND CLOSED THE EXTERNAL VALVE. HE NOTIFIED THE SHIPPER WHO CALLED THE FIRE DEPT. AS WELL AS THE OTHER AUTHORITIES. OUR DRIVER AND THE SHIPPER PERSONNEL CONTAINED THE PRODUCT AS BEST THEY COULD. WE ENGAGED OH MATERIALS TO CLEAN UP THE SPILL AREA. IT APPEARS THAT OUR DRIVER FAILED TO INSURE THAT HIS TRAILER WAS PROPERLY SECURED PRIOR TO LOADING THE MATERIAL.
