OUR UNIT WAS ATTEMPTING TO UNLOAD STYRENE AT THE CONGINSEE PLANT. OUR DRIVER THOUGHT THE FACTOR PRODUCT PUMP HAD A VAPOR LOCK IN IT AS NO PRODUCT WOULD FLOW TO THE PUMP FROM THE TRAILER. OUR DRIVER BROKE THE CAM BACK BITTINGS HOLD DOWN EARS LOOSE ON THE SUTTON HOSE AT THE PRODUCT PUMP. WHEN HE LOOSENED THE HOLD DOWN EARS THE FEMALE FITTING BLEW OFF THE PUMP CAUSING AN APPROX 175 GALLONS OF PRODUCT TO SPILL INTO THE CONSIGNEES CONTAINMENT AREA. THE PLANT CLEANED UP THE SPILL.
