There is damage to the the ANC vehicle #308713 to the extent that it will need to be towed, and the damage to our truck has caused the tank to leak.

At this moment the ANC driver is saying she is not injured but HV Care has been contacted as a precaution.

The driver of the Red Bull vehicle is saying he is not injured.
