According to the information obtained, the following occurred. Approximately 10 gallons of free product were released onto asphalt. Apparently, as a result of a loose tank cover. Allstate Power-Vac of Twin Oaks, PA performed cleanup of the free product using oil dry. The cleanup materials were placed into two (2) thirty (30) gallon drums and sent to Eldridge Environmental Facility for disposition via landfill.
