Quick Fuel driver was travelling Northbound on Highway 85 and gasket on outlet fitting of pump failed releasing #2 dyed diesel fuel from exit #104 Pleasant Hill Road on Highway 85 then continuing Eastbound on Highway 316 through the Sugarloaf Parkway exit to the intersection of Sugarloaf Parkway and Old Norcross Road. The majority of the fuel was released at the intersection where the Gwinnett County Highway Department layed sand on the spill and along Northbound highway 85 and Eastbound highway 316. The Fire Department and Highway Patrol were dispatched to the scene. Fire Department personnel were able to tighten bolts on the pump flange which stopped the fuel from releasing any further. Emergency Management Inc, dispatched an environmental cleanup company, Environmental Protection Services, to clean up the #2 dyed diesel fuel. Eight drums of absorbent material and #2 dyed diesel fuel was generated during the cleanup process. fuel on the cargo tank truck was pumped into another cargo tank truck and the damaged truck was towed off scene to a tank repair shop.
