on 3/17/07 at 0900 T ASD crew were dragging a cut of loaded coal cars on the Old Dump Lead at the AL State Docks McDuffie Island Coal Handling Facility when T ASD Locomotive's 771 and 772 derailed along with two loaded coal cars causing the fuel tank to rupture on locomotive 771, discharging 850 gallons of bio diesel fuel between the Old Dump Lead and the Middle Loop track. The T ASD yardmaster notified the AL. State Docks Protection Department and the Mobile Fire department was dispatched to the scene. United States Enviromental was contacted and arrived on the scence at 1000 along with an Al. Department Enviromental Management representative. McDuffie Island employees assisted in containment of spill using oil dry. In house clean-up using backhoes was used to remove contaminated dirt and coal which was set to the roadside clear of the Old Dump Lead. United States Enviromental Services arrived on 3/19/07 at 0830 with equipment and four roll on boxes and removed contaminated dirt and coal to dispose at the Macland Disposal Center located in Moss Point Mississippi.
