DRIVER PULLED ONTO CUSTOMER SCALES AND WAS WEIGHED HEAVY. HE WAS THEN INSTRUCTED TO DRIVE TO UNLOADING AREA. DRIVER WAS SHOWN WHERE TO HOOK UP HOSE TO OFFLOAD. CUSTOMER SIGNED HIS PAPERWORK THAT THEY COULD HOLD PRODUCT AND THEN LEFT DRIVER WHO PROCEEDED TO UNLOAD. THE TANK DRIVER WAS UNLOADING INTO WAS INSIDE THE BUILDING AND UP ON 2ND FLOOR. DRIVER COULD NOT SEE TANK AND HAD NO ACCESS TO TANK DURING UNLOADING. AFTER FINISHING UNLOADING, THE DRIVER UNHOOKED HIS HOSES AND WENT TO WEIGHT EMPTY. AT THIS TIME DRIVER WAS RELEASED AND PAPER WORK SIGNED. DRIVER WAS NOT AWARE THE CUSTOMER'S TANK HAD OVERFILLED AND RAN INTO THEIR WATER TREATMENT AREA UNTIL NOTIFIED BY THE SHIPPER THE FOLLOWING DAY. THE SHIPPER SHIPPED TOO MUCH PRODUCT AND CONSIGNEE FAILED TO WATCH THEIR TANK DURING UNLOADING.
