OUR DRIVER AT A CUSTOMER SITE (FINDINGS INC.) TO MAKE A BULK DELIVERY OF ANHYDROUS AMMONIA. WHEN HE WAS UNREELING HIS HOSE LINE THE HOSE PULLED APART FROM ITS SWAGGED COUPLING. THE BREAK OCCURRED IN THE TRAILER'S CABINET WHERE THE HOSE IS CONNECTED TO THE HOSE REEL. THE HOSE IS APPROXIMATELY 100 FEET LONG AND 1 INCH IN DIAMETER. THE HOSE CONTAINED SOME AMMONIA LIQUID AND VAPOR, AND IT ESTIMATED THAT 10 TO 50 LBS. OF AMMONIA WAS RELEASED. THE RELEASE WAS CONTAINED ON SITE AND DISPERSED TO THE ATMOSPHERE. THE KEENE (NEW HAMPSHIRE) FIRE DEPARTMENT WAS NOTIFIED AND RESPONDED, SIX (6) PERSONNEL FROM FITTINGS, INC. WERE TRANSPORTED TO THE HOSPITAL AND RELEASED. THE EMPLOYEES OF FINDINGS (APPROXIMATELY 100 PERSONNEL) WERE EVACUATED FOR APPROXIMATELY 1 HOUR.
