WHILE ATTEMPTING TO BRING THE VEHICLE BACK ONTO THE ROADWAY, THE SIDE OF THE TRAILER STRUCK A CULVERT/ MOUNTAIN WHICH CAUSED DAMAGE TO THE REAR OF THE TRAILER. THE DRIVER OVERTURNED. PRODUCT SPILLED FROM THE RUPTURED TRAILER ONTO THE BERM OF THE ROADWAY AND RAN INTO AN UNNAMED TRIBUTORY. THIS UNNAMED STREAM LEAD TO MILL CREEK. PRODUCT WAS SPILLED INTO MILL CREEK AND THE ALLEGHENY RIVER MONITORED. SPILL CLEANUP CONTRACTORS WERE ON SITE TO ASSIST WITH REMEDIATION OF THE SPILL. ALL REGULATORY AGENIES WERE NOTIFIED AND WERE ON-SITE.
