THE RELEASE OCCURED DUE THE OVERLOADING OF A PHENOL RAILCAR AT OUR FACILITY. THE LOADING OPERATION WAS DELAYED INTO THE EARLY HOURS OF SEPTEMBER 3RD DUE TO LACK OF PHENOL INVENTORY AT THE TIME. WITH SUFFICIENT INVENTORY, THE OPERATOR BEGAN LOADING THE RAILCAR AND INADVERTENTLY FELL ASLEEP IN THE LOAD MONITORING SHACK LOCATED CLOSE BY. AT THE POINT THAT THE LOADING OPERATION WAS SHUT DOWN, APPROXIMATELY 4000 # OF MOLTEN PHENOL HAD OVERFLOWED THE TOP OF THE RAILCAR.
