ACCORDING TO OUR DRIVER, AND THE INVESTIGATING OFFICER IT WAS DETERMINED THE DRIVER WAS TRAVELING APPROX. 46 MILES PER HOUR, WHEN HE HAD A BLOW OUT ON THE RIGHT SIDE OF THE TRACTOR. HE WAS NOT ABLE TO CONTROL THE TRUCK/TRAILER AND IT TRAVELED TOWARDS THE GUARDRAIL & TURNED OVER. THE VEHICLE CAME TO REST ON ITS SIDE, ABOUT 258 FEET AFTER IT MADE CONTACT WITH THE GUARDRAIL. THE DRIVER GOT OUT OF THE TRUCK WITHOUT INJURY. AFTER SEVERAL MINUTES AFTER THE DRIVER EVACUATED THE TRUCK HE NOTICED A SMALL FIRE WHICH RESULTED IN BOTH THE TRACTOR AND TRAILER BURNING COMPLETELY.

WE LET THEM KNOW THAT ALTHOUGH THEIR TRACTOR AND TRAILER MAY HAVE NEW TIRES AND THEY MAY TRAVEL THE SAME ROUTES DAY AFTER DAY TO NEVER TAKE A TRIP FOR GRANTED. WE ALSO REMINDED THEM, THIS IS WHY THE PRE-TRIP AND POST-TRIP INSPECTIONS ARE SO IMPORTANT.
