THE CAMEO TRUCK STOP TANKS ARE ALL MANIFOLDED TOGETHER. OUR TRANSPORT DRIVER OPENED A VALVE TO THE WRONG TANK AND BEGAN PUMPING OFF HIS CARGO. THE TANK OUR DRIVER WAS PUMPING INTO WOULD NOT HOLD THE ENTIRE LOAD SO THE STORAGE TANK WAS OVERFILLED. SPILLED FUEL CAME OUT VENT PIPES AND ENTERED THE CONTAINMENT AREA AROUND THE TANK FARM. WE PUMPED AS MUCH FUEL AS POSSIBLE FROM THE CONTAINMENT AREA - APPROXIMATELY 450 GALLONS AND DISPOSED OF IT AT AN APPROVED FACILITY. WE THEN REMOVED THE CONTAMINATED GRAVEL THAT LINED THE CONTAINMENT AREA AND PLACED IT ON A SHEET OF VISQUEEN WHERE IT WILL BE LAND FARMED AND DRIED. CLEAN GRAVEL WAS PLACED IN THE CONTAINMENT AREA. OUR DRIVER WAS PLACED ON PROBATION FOR A 6 MONTH PERIOD OF TIME FOR FAILURE TO PROPERLY CHECK TANKS BEING FILLED AT THE TANK FARM. HE WAS ALSO GIVEN FURTHER INSTRUCTION FROM THE CAMEO FACILITY ABOUT THEIR MANIFOLDING SYSTEM.
