The propane bobtail was traveling east on highway 126. The right front and rear tires left the roadway. The tires struck a cement culvert and caused the vehicle to roll 2-3 times. As a result, the propane fill valve was sheared off. The excess flow valve activated correctly and only a very small vapor release resulted. The propane was offloaded into another vehicle and the wrecked vehicle was transported to the service yard. No cleanup was required.
