AT APPROXIMATELY 6:30 AM ON 9/23/03, A LOW SPEED (15 MPH) COLLISION INVOLVING TWO TANKER TRUCKS (CARGO TANKS) OCCURRED WITHIN THE TERMINAL YARD AT THE GLOBAL PETROLEUM CORP, LOADING RACK LOCATED ON 140 LEE BURBANK HIGHWAY REVERE MA. THE ACCIDENT OCCURRED AS ONE TANKER TRUCK WAS BACKING OUT OF BAY #11 WITH AN ANOTHER TANKER TRUCK DRIVING ALONG THE LOADING RACK. THE COLLISION SHEARED OFF ONE OF THE TANK COMPARTMENTS MANIFOLD VALVE AND DREAD FUEL BEGAN LEAKING OUT OF THE COMPARTMENT ONTO THE PAVED SURFACE. YARD PERSONNEL IMMEDIATELY SEALED THE MANIFOLD PIPE, HOWEVER A 1200 GALLONS WAS RELEASED. CLEAN HARBOR WAS RETAINED AS THE 'CLEAN UP' CONTRACTOR. THE RELEASE WAS CONTAINED ON THE PAVE AREA, NO STORM DRAIN OR COOLER BODY WERE IMPACTED. THE WASTE GENERATED WAS DISPOSED OFF UNDER UNIFORM EPA MANIFEST RULES.
